## **Approval of Minutes**

The minutes from the March 3, 2021, general meeting was distributed to the board members via email and in person at the April 7, 2022, general meeting by Beverly Embry.

A motion was made to accepted and approve the above-mentioned meeting minutes was made by Dave Kamen. It was approved by Eileen Eckert and second by Christine Lent. All board members were in favor.

### **Director Report**

Directors Report started with Mr. Guillen thanking ABBI for their support. Upcoming events for music groups: Jazz Cab and Music in the Parks. At the end of the month, we will be hosting NYSMMA Solo Festival. The event will be kept small, and they will fund the food within the school. No ABBI support needed. All bands are preparing for their upcoming Spring Concerts.

- Question from Eileen- Are the ensembles playing in the LaGrange Day?
  - LaGrange day is only being held for one (1) day and not the whole weekend.

- Union Vales Community Day is the day before Graduation.
- If ensembles are performing, let ABBI know so we can represent.

Mr. Rzodkiewicz reported the amount we are supposed to get back from BOCES is incorrect. It will be less than 400 but he will confirm and get back to us. He mentioned he forgot to inform ABBI of the previous middle school concerts. He would like to have 1 to 2 ABBI members at the upcoming middle school concerts. Preliminary numbers for bands are up 25%. This is close to where we should be. Mr. Rzodkiewicz is looking for groups to come in and work with students. Orchestra does this now with its groups.

- Line item needs to be added to the budget for the money we get back from the BOCES Art and Education program.
- Nicole suggested to reach out to the Bardavon. The Hudson Valley Philharmonic works with the Bardavon. Nicole will send the information to Mr. Guillen and Mr. Rzodkiewicz.

Mr. Keech reported Winter Guard has finished their season and will hold their annual Ice Cream Social on April 18, 2022. Percussion will finish its competition season this weekend. Fall Marching Band will hold sessions for all groups before the end of the school year. The leadership team will be announced after this weekend. The Marching Band schedule is 98% complete. This year's show will be more like the 2019 show. All contemporary and seen on Broadway. The Invitational (home show) is on the schedule and confirmed. May 22nd is the kickoff meeting for Marching Band.

#### **President's Report**

Dave reported he made an error when he was working on Music in the Parks. Vote was done at the March 3<sup>rd</sup> meeting.

Learn, Play, Grow, grant proposed spending is as follows:

\$14,393 Sound System

Working with Brandie Lane from Winter Percussion on the Sound System. The system will be like the one in the auditorium and it will include everything but the soundboard. We can sell the old system on the ABBI marketplace. The new system will be used by all groups. The decision to take the funds from the grant will prevent it from coming out of the upcoming tour fees. We are purchasing the system form a Alto Music, a local business on Route 9.

- We need to wrap up the grant by August.
- Receipts must be submitted within 60 days of purchase to Mr. Wraftner.

A motion is on the floor from Dave Kamen for the approval of the spending of the grant as listed above. The motion to accept the spending of the \$20,000 Learn, Play, Grow grant as listed above was accepted by Beverly Embry and second by Eileen Eckert and Nicole Raskopf. All Board members approved.

Dave reported we were not selected for the Vassar College consulting project.

The ABBI shed needs a new roof. We need funding from ABBI. Who do we contact from the school? Directors suggested Eric Allen. Jess Schleicher- Woodshop class from the school may be able to build shed (1/2-year class). We need volunteers to find plans and figure out costs? Do we get the school or someone from the outside the school to build? We may be able to go to ReStore store and get shingles. The roof should last another year.

#### WHO HAS THE SHED KEYS?

Eileen Eckert, Judy McGuire has keys? Mr. Guillen has a key?? Do we have 4 or 5 keys? Judy handed Christine Lent her key at the meeting. The yellow one. Mr. Guillen brought a Square reader from his office and gave to Christine Lent.

Dave has a new job and will be doing a lot of traveling in May and June.

Mr. Keech mentioned we should also have ASOA represented at the middle school concerts.

### **Vice President Report**

### Winter Guard (Eileen)

Eileen reported the Spaghetti Dinner/Home Show brought in a profit over \$6000. The team placed 2<sup>nd</sup> in the WGI Philly Regional and 2<sup>nd</sup> in the Mid York Championships.

Middle School Guard finished 5<sup>th</sup> out of 9. Possibility of 31 guard for the upcoming Marching Band season.

## **Treasurer Report**

#### Additional Discussion about finances:

Brian Laferriere reported that IBM has changed their volunteer match program. ABBI no longer matches IBM grants requirements because we fundraise. Brian said after 40 hours of volunteer work IBM would give \$500. They give \$100 for every 10 hours of volunteering and if you hit 40 hours, they give \$500. They are no longer matching. Eileen asked where to find the link for IBM employees?

Dave Kamen reported from the BYLAWS Section 5-1.3B. The bylaw states the Treasurer needs an audit by professional. We want to be transparent. When was the last time Scott has done an audit? August 2015 manual of Quickbooks. Bylaws state every year. Does preparing taxes count? Nicole said no. It is very thorough and expensive. Can we make an audit committee?? Nicole will investigate. Action item that needs to be done by July.

Tickets will go on sale after Spring Break. Each student will sell 5 tickets. Matt is setting

up photo booth and doing photography. They are all set with volunteers and will host a 50/50. They will sell extra votives, merchandise and Jazz Magnet. Eileen suggested a

scratch off board with their 50/50 raffle.

## **#1 Sound System**

The system as I requested it is involves QSC products and QSC is hopelessly back ordered due to supply chain issues. According to Alto Music, they are not even accepting new orders, and there is no indication of an end to their shut down. So, I went back to Brandie and she recommended the JBL products. They are definitely better (her first choice if money was not object), but the problem was that the JBL system price was nearly \$20,000. I told Alto music that we have about \$14,000 to spend and that I might be able to go a little bit more but could not do \$20k. Dave Reuter, the head of the Wappinger store came back with the quote you see attached..... \$16,500!!

Then it occurred to me that we will be making an announcement soon that the AHSMB placed 3rd in the Long Island University Virtual Band Contest and will be receiving a check for \$2,500! So, my thought was to go for purchase of the JBL speakers which should be available in 3 months. Between Alto Music bid, the grant, and the prize money, we have this all covered.

Alto Music would need 25% of \$16,500 (\$4,125) to place the order. Should I proceed? I don't believe this would take a ABBI vote, but I didn't want to make these changes to the plan without informing anyone.

Vote went as follows: 8 voted YES and 2 abstained

### **#2 Devon Williams Jr. Scholarship Donation:**
