Concert Bands will performing soon. May 25th will be the Wind Ensemble and Concerto performance and the other concerts will be held the Tuesday after Memorial Day.

Webmaster (Alan and Jess)

WEB HOSTING

===========

We need to renew our contract for web hosting at Bluehost. When I say "web hosting" I'm talking about our Wordpress-based web site and all of our e-mail accounts. It is essentially our tiny part of a large shared web server in "the cloud" (where "the cloud" means nothing more than "someone else's computer, hopefully in a well-managed data center") that's used to publish our web site to the world and process our e-mails. Web hosting is separate and apart from renting our domain name (ABBImusic.org), which is not due to be renewed until 6/24/2025.

On May 20, 2019, ABBI paid \$178.20 for 36 months of web hosting and e-mail processing. That's only \$4.95 per month. It must have been a (very good) introductory rate because the renewal for another 36 months is going to cost \$683.64, which is \$18.99 per month. That's annoying, but we don't have much of a choice.

2nd email:

I looked into web hosting on Digital Ocean, which is the platform I use for my own web sites (which are quite small). We could rent a "droplet" from them for about \$6/month for a shared server that should handle our needs in terms of storage and bandwidth, but that's only for the hosting. (I assume I could install Wordpress on it and use their droplet to run our site.) But we'd still need an e-mail system. I like Hover.com (again, for my own small purposes) but they are \$20/year per user. We currently have 43 e-mails configured (though we could -- and perhaps should -- trim those down and eliminate addresses no longer in use), which is \$860 per year. (Maybe e-mail is really the expensive part of this,

more so than hosting.) Of course, I could try to install SquirrelMail or Roundcube on our droplet for e-mail. But once we integrate the e-mail we *might* need a more powerful droplet, which would make it \$12/month from Digital Ocean. The problem is that this is a manual configuration requiring manual maintenance from a server geek rather than an "all in one" integrated solution meant for end-users. There is value to what Bluehost offers us in that regard.

Meeting information:

We ordered 4 card readers and 4 lightening connectors. We need to get on the school wifi to use the Square readers. We need to set up access to WIFI with a password for ABBI. Reach out to Carlos. Need to test readers before Jazz Cab.

Renewal of Website- received a \$200 discount. The original offer (introductory rate for 5 years at \$5 per month. The new offers are as follows:

- Original \$18.99 per month choice plus for 3 years. (\$683.64)
- Discount \$13.49 per month for 3 years. (\$485.64)

The new plan is in the cart ready for purchase and tax id number needs to be added to the cart to avoid tax. Alan will reach out to Judy. Later in the meeting Judy messaged saying she had WIFI access.

TechSoup: Fees not worth it. Charge administrative fees to provide us with reduced software. Offer online courses in grant writing and event planning. Need to participate in case studies. Etc. How much are we really saving? Have Alan and Nicole touch base with each other for QuickBooks.

ADA Compliance for website:

There is no way to be 100% compliant. The plugins (WordPress) are not free and do not cover everything. Ran a diagnostic report (accessi.org) and it tells you what's wrong and what code is wrong. The report was 35 pages. We have a lot of code issues. Alan will fix the 11 pictures that do not have alt-text. Jess will send the 35-page report to Alan to look over. We need to provide an accessibility statement page on the website along with our identified goals and issues, and a contact form. This should cover us until we fix everything. Option to pay \$279 a year or \$27 a month for an AI to do you website for you. Most other companies start at \$40 a month. We will try to fix it ourselves first.

According to Alan website is not that big, let's clean it up. We do need some new updated photos. Updates for plugins and themes in the system. Jess updated the plugins.

- Dave recapped the Website information. Contrast hard to read. 11 pics not in alt text. Skip to can't use mouse. People are looking to access the old Google drive information for documents. Institutional knowledge page for information, passwords to Dave and Eileen. Keep Google Drive for back up.
- Scholarship information is over to Alan already. Scholarship information is live right now on the website.
- Jess is going to share an Army Band scholarship for Seniors on the website.

ASOA (Paula)

Discussed buying ads for each group like Arlington Admirals and ASOA events and ABBI events.

Vice President (Eileen email)
